#### SELDEN SOCIETY 2018 LECTURE SERIES – GUNS AND JUDGES: ANTONIN SCALIA AND THE RIGHT TO BEAR ARMS

Antonin (Nino) Scalia was, for many years, the best known member of the Supreme Court of the United States. He was charming, mercurial, polarising and stubborn. Scalia was a member of the court for nearly 30 years until his unexpected death in 2016 at the age of 79.

During his judicial career, Justice Scalia was influential in many respects, but – some might say – not in the ways that were initially expected of him. His dissents worked to promote 'originalism' as a means of interpreting the US Constitution. In one of the most influential decisions of the last 25 years, Scalia wrote the majority opinion in *District of Columbia v Heller*. It was the first extensive decision on the Second Amendment and the right to bear arms. He engaged in a lengthy historical exposition and a grammatical analysis of the amendment. This decision changed the previously accepted understanding of the amendment and it is often mistakenly thought to support the abolition of all restrictions on gun ownership.

# THE 2018 SUPREME COURT OF QUEENSLAND ORATION – CRITICISM OF THE COURTS AND JUDGES INFORMED CRITICISM OR OTHERWISE

The freedom of speech and of the press are proven precious rights, not only in Hong Kong but throughout common law jurisdictions. They benefit society and no one and no institution, especially public ones, should be exempt from either adverse comment or criticism. However, where the public interest is adversely affected, different considerations come into play. In the context of the courts, there has been a noticeable trend that criticism of the work of the courts and of judges has become much less restrained than before, even sometimes to the point of being personal and at times abusive. Ought we be able to brush such criticisms aside or can more be done to enable criticisms to be based on commentators being better informed? After all, one valid criticism of the law is that not enough is done to explain how the administration of justice works in practice. What does 'being better informed' actually mean and is relevant information about the courts readily available in the first place? These are questions that provoke a discussion about the rule of law itself, particularly in Hong Kong.

### EDITORS' SELECTION OF NEW QUEENSLAND CASES

CRIMINAL LAW – DANGEROUS SEXUAL OFFENDER – WHETHER COURT REQUIRED TO GIVE REASONS AT THE TIME ORDER IS MADE RELEASING OFFENDER FROM A SUPERVISION ORDER – SECTION 17 DANGEROUS PRISONERS (SEXUAL OFFENDERS) ACT 2003

Attorney-General (Qld) v Yeatman [2018] QSC 70 1

In this decision, Justice Davis gives his reasons for his decision to release the respondent from a supervision order. An issue arose as to whether s 17 of the DSPOA operated to prevent his Honour from making the order without at the same time delivering reasons. His Honour explains that an order to release the respondent under the existing supervision order does not engage s 17 and contemporaneous reasons were not required.

Davis J 9 April 2018 The respondent was subject to a supervision order made on 30 June 2014 imposing numerous conditions. [1]. The Attorney-General brought the present application seeking orders under s 22 of the *Dangerous Prisoners (Sexual Offenders) Act* 2003 (**DPSOA**), alleging the respondent had contravened the order on 14 December 2017. The respondent admitted he contravened the order by telephoning a woman contrary to the directions of Corrective Services officers. [18]. The contravention having been proved, the real contest was whether the respondent had satisfied the court that the adequate protection of the community could be satisfied by releasing him from the supervision order. [22]. Davis J found that he was satisfied and released the respondent upon the supervision order in its existing form with reasons to follow. [2], [3]. This raised a question as to the application and proper construction of s 17 of the DPSOA.

Section 17 provides that a court must give detailed reasons at the time of making "a continuing detention order", an "interim detention order", a "supervision order" or an "interim supervision order". [29]. Each of these orders is made under Div 1 or 3 of Pt 2 of the DPSOA. [30]. His Honour noted that if, under s 22, the supervision order was revoked and a continuing detention order was made then s 17 would clearly be engaged; the court would be "making" a continuing detention order. [31].

However, an order releasing the respondent under the existing supervision order is not the "making" of a supervision order. It is an order made under s 22 releasing the respondent. Therefore, s 17 was not engaged and was not offended by the giving on reasons on a later date. [31].

#### CRIMINAL LAW – APPEAL AGAINST CONVICTION RECORDED ON GUILTY PLEA – WHERE PLEADED GUILTY TO ASSAULT OF NURSE – WHERE IN "OVERWROUGHT EMOTIONAL STATE" AT TIME OF OFFENDING – WHERE SENTENCE QUASHED DUE TO UNUSUAL COUNTERVAILING FACTORS

#### R v Ganeshalingham [2018] QCA 34 ☆

In this case a refugee sought leave to appeal against sentence having pleaded guilty to having seriously assaulted a nurse. The evidence was that the applicant was in an "overwrought emotional state" and that his attempt to hug her was not motivated by "criminal intent but rather by a mistaken but unreasonable belief that his embrace would not be rejected." The court found that it was an appropriate case to release the offender under s 19 of the Criminal Code and exercise the discretion not to record a conviction under s 12 of the Criminal Code.

12 March 2018

In this unusual recent matter, an application for an extension of time to appeal against sentence, the court quashed a sentence (albeit a wholly suspended term of imprisonment) against a refugee who had assaulted a nurse whilst in an "overwrought emotional state". The reasons were delivered *ex tempore* by the President.

The circumstances of the offending were highly relevant to the appeal's outcome. The applicant, a Sri Lankan national, had been subjected to a fraught course of events prior to his arrival, via passage on a boat, in Australia. Upon his arrival, he was held in detention for six years, during which he was granted refugee status. He was found to be suffering from post-traumatic stress disorder, accompanied by flashbacks, nightmares and elevated anxiety levels.

Ultimately, the applicant overdosed on sleeping tablets and was admitted to hospital. Whilst at hospital he encountered a kind nurse and, overcome emotionally, behaved inappropriately towards her and was thereafter charged with serious assault under s 340(2AA) of the *Criminal Code*. In the aftermath of that incident he made partial admissions and indicated that his behaviour had been prompted by the fact that the "nurse's solicitude for him was the first act of kindness he had experienced since coming

to Australia". He was very remorseful, with treating psychiatrists suggesting that his mental state at the time may have been adversely affected by his overdose of medication and his being distressed and wanting emotional support, coupled with an "unfamiliar[ity] with cues for touching or hugging a female in the local culture".

Given the applicant's inauspicious personal circumstances at sentencing his Counsel argued in favour of an order under s 19 of the *Penalties and Sentences Act* 1992, which enables a Court to release the offender absolutely or to make an order that the offender be released if the offender enters into a recognisance to be of good behaviour and to appear for conviction and sentence if called upon. The President agreed that claims of general deterrence and the need for denunciation "were significantly reduced in this case". On appeal, his Counsel for the applicant highlighted two additional matters which, he submitted, had not been considered at sentencing and consequently had led to error: namely, that the applicant had not been motivated by aggression nor sexual gratification, and the lack of any sentencing precedent justifying the imposition of a term of imprisonment in such a case.

Ultimately the court, whilst having due regard to the emotional harm done to the complainant, determined that in view of the unusual countervailing factors, the appropriate course was to grant the extension and leave to appeal, with no conviction recorded and no further punishment. In making those orders the President observed:

"... the applicant's overwrought emotional state and his nurse's compassion and sympathy evidently urged him to seek to hug her in a way that was, to her, intrusive and shocking. The background of facts supports the conclusion that the applicant's acts were not the result of a criminal intent to assault his helper; rather, he committed an assault because of a mistaken but unreasonable belief that his embrace would not be rejected."

#### PROFESSIONS AND TRADES – LAWYERS – COMPLAINTS AND DISCIPLINARY PROCEEDINGS – WHETHER SOLICITOR SHOULD BE REMOVED FROM ROLL OF LEGAL PRACTITIONERS – WHETHER TRIBUNAL ERRED IN FAILING TO PROPERLY APPLY TEST OF PROBABLE PERMANENT UNFITNESS TO PRACTICE – WHERE MISCONDUCT SUCH THAT SOLICITOR OUGHT TO BE REMOVED FROM ROLL

## Attorney-General of the State of Queensland v Legal Services Commissioner [2018] QCA 66 \approx

This decision arises out of events relating to the Gordon Nuttall corruption saga. Mr Shand was a solicitor found guilty of making a corrupt payment in 2002 to Mr Nuttall who was a Minister of the Crown. On the basis of that conduct, the Legal Services Commissioner applied to the QCAT to have him struck off the Roll of Legal Practitioners. Despite a finding of professional misconduct the QCAT refused to recommend that Mr Shand be struck off. On appeal the court found that QCAT had failed to properly apply the test of permanent unfitness to practice and ordered Mr Shand be removed from the Roll of Legal Practitioners.

Morrison and McMurdo JJA and Brown J

#### 13 April 2018

Here, the court considered whether a solicitor who had committed an offence against s 442BA of the *Criminal Code* of making a corrupt payment to a Minister of the Crown in 2002 ought be struck from the Roll of Legal Practitioners, in addition to existing disciplinary orders against him. [37].

The Tribunal recorded a finding that the respondent had engaged in professional misconduct and ordered that a local practising certificate not be granted to him before the expiry of five years from the date of the order; and further ordered that the respondent pay the Commissioner's costs. [5]. Before

the Tribunal the solicitor had admitted professional misconduct but offered an undertaking to never reapply for a practising certificate. [22].

On appeal, the applicants argued that the Tribunal erred in not recommending that the respondent's name be removed from the Roll. [6].

Section 456 of the *Legal Profession Act* 2007 enables the Tribunal, in the event it is satisfied that the practitioner has engaged in unsatisfactory professional conduct or professional misconduct, to make any order as it thinks fit, including but not limited to:

- (a) an order recommending that the name of the Australian legal practitioner be removed from the local roll;
- (b) an order that the practitioner's local practising certificate be suspended for a stated period or cancelled;
- (c) an order that a local practising certificate not be granted to the practitioner before the end of a stated period.

The discretion conferred by s 456 is not expressly constrained. The purpose of the provision is not to punish the respondent, but to protect the public. [52]. In terms of orders that unfit practitioners be removed from the Roll, in *Attorney-General v Bax* [1999] 2 Qd R 9, 22 Pincus JA commented that the remedies of suspension or striking off are wider than merely preventing solicitors from practising and extend to protection of the public and of the profession's standing and that further, there is a deterrent element. In this respect, his Honour Justice McMurdo pertinently added:

"The community needs to have confidence that only fit and proper persons are able to practise as lawyers and if that standing, and thereby that confidence, is diminished, the effectiveness of the legal profession, in the service of clients, the courts, and the public is prejudiced. The Court's Roll of practitioners is an endorsement of the fitness of those who are enrolled". [55].

In assessing the Tribunal's reasons and ultimately allowing the appeal, the court's view was that in addressing the question of whether the respondent was guilty of professional misconduct the Member had applied the wrong test. He concluded that at the time of the hearing the respondent was not a fit and proper person to engage in legal practice, (as distinct from when the transgression occurred, some fifteen years prior). [25], [51]. The court's view was that that determination should have been whether the respondent remained unfit to practice. What needed to be addressed was whether the respondent's character was so indelibly marked by the misconduct that he could not be regarded as a fit and proper person to remain on the roll. [57].

The court further held that the Tribunal erred in not considering all of the purposes which are to be served by orders made under s 456, (for example preserving the good standing of the legal profession and of the Roll); and that it could not endorse its determination that the respondent, if then unfit to practise in 2017, was not permanently so. In that regard, McMurdo JA noted that at the time the offence was committed, the respondent was aged 51 years and his case was simply not that of:

"an inexperienced young person who had become wiser and more responsible with the passage of time ...Nor was this a case where he was suffering from any illness which contributed to his offending. After the passage of 15 years, if he remained unfit for practice, there was nothing in the evidence ...to suggest any likelihood that he would become a fit and proper person to be on the Roll." [59].

#### EQUITY – TRUSTS AND TRUSTEES – PROCEEDINGS BETWEEN TRUSTEES AND BENEFICIARIES OR THIRD PARTIES — WHETHER BOARD GAVE PROPER INFORMED CONSIDERATION TO AN APPLICATION FOR PAYMENT FOR TOTAL AND PERMANENT DISABILITY – SECTION 8 *TRUSTS ACT* 1973

## Board of Trustees of the State Public Sector Superannuation Scheme v Gomez [2018] QCA 67 ☆

This case involved appeals from a review of a decision by QSuper to decline an application for the payment of a Total and Permanent Disability benefit to a member. In the course of dismissing the appeals, Henry J made some important observations on the risk that an applicant faces if they do not provide sufficient information to the trustee decision-maker, even where the trustee may be expected to make further inquiries as part of their duty to give proper consideration.

13 April 2018

#### Background

Mr Gomez was a nurse at the Princess Alexandra Hospital. In 2011, he sustained an injury to his shoulder when lifting a patient. The material consequence was an inability to raise his arm above shoulder level or to apply material force with it. He has not worked at the hospital since. [1], [11], [13]. As a member of the State Public Sector Superannuation Scheme ("QSuper"), Mr Gomez subsequently applied to the Board for payment on the alleged basis that he had "total and permanent disablement" ("TPD"). [4], [20]. The Board rejected his claim in three separate decisions, the latter two of which were in the nature of 'applications to reconsider' and arose after the provision of further information by Mr Gomez. [5]. The further information concerned his suitability for certain jobs. [92].

At first instance, Mr Gomez applied for review of the Board's decisions pursuant to s 8 of the *Trusts Act* 1973. [29]. The primary judge considered that there was no utility in reviewing the first decision and that the second decision was reasonably open to the Board. [45]. However, with respect to the third decision, his Honour concluded that Mr Gomez had put forward sufficient material to "show there was a case to be investigated further". The new material revealed a reasonable likelihood of producing a different result if properly considered (see *Gilberg v Maritime Super Pty Ltd* [2009] NSWCA 325). [27]–[28], [80]. The failure to properly consider the new material and investigate further was a breach of QSuper's duty to properly consider the application (see *Finch v Telstra Super Pty Ltd* (2010) 242 CLR 254). [24], [80]. The primary judge ordered that the Board reconsider Mr Gomez's application according to law. [81].

#### In the Court of Appeal

On appeal, the Board sought to have the order to reconsider the application set aside. It primarily complained that the trial judge had erred in holding that the new information raised a reasonable possibility of a different result. [83]. Mr Gomez cross-appealed in respect of the dismissal of his case concerning the second decision, and in respect of costs. All of the grounds in both appeals were unsuccessful, with Henry J giving the Court's reasons (with which Sofronoff P and Fraser JA agreed). [1]–[2], [123].

A noteworthy aspect of the decision was the consideration given to the role of an applicant for payment in making their case, in a context where they bear no explicit onus of proof, and where the trustee owes a duty to properly consider that includes an obligation to make further inquiries in some circumstances. [51]. Henry J noted (at [53]):

"There is obviously an element of risk involved in a member merely sitting back and hoping the Board will regard information adverse to the application as unconvincing and or warranting further inquiry."

His Honour said that the risk was particularly high when a member provides only equivocal or incomplete support for their application, and then elects not to advance further information to contradict information adverse to them:

"In such a case the Board may logically infer from the paucity of information supporting the application and the lack of contradiction of information adverse to it that it can more safely act upon the adverse information without further inquiry."

In this case it was "unfortunate, and perhaps frustrating" that Mr Gomez had not provided the further information prior to the second decision. Nonetheless, it was clear that the information had not been properly considered. [92]. The appeals were dismissed. [123].

#### ASSOCIATIONS AND CLUBS – EXPULSION, SUSPENSION AND DISQUALIFICATION – POWER TO EXPEL, SUSPEND AND DISQUALIFY – WHETHER CLUB PROVIDED A FULL AND FAIR OPPORTUNITY TO MEMBER TO PRESENT HER CASE

#### Petersen v Proserpine Golf Club Inc [2018] QSC 71

The applicant in this case had been a member and, since 2008, a life member of the Proserpine Golf Club. The club made three decisions to suspend the applicant's membership and finally a decision to terminate the applicant's membership. The facts were similar to those in Gould v Isis Club Inc [2016] 1 Qd R 363. The issue for determination before North J was whether the applicant had been afforded a full and fair opportunity to present her case before each decision was made.

North J

11 April 2018

The applicant had been a member of Proserpine Golf Club since 1965 and in 2008 was afforded the honour of life membership. However, in 2015 the club decided through the committee to terminate the applicant's membership. [2]. The applicant sought a declaration that the three decisions made by the club in terminating the applicant's membership be declared void and set aside. [2]. The application raised the issue as to whether the club had afforded the applicant a "full and fair opportunity of presenting [the applicant's] case" (cl 7.4 of the club's constitution). [7]. This raised issues of natural justice or procedural fairness.

Both parties referred to McMeekin J's decision in *Gould v Isis Club Inc* [2016] 1 Qd R 363 in which McMeekin J explained that although a lower threshold of procedural fairness can be expected of social clubs "in circumstances of expulsion or suspension, where the effects are more serious reasonably strict adherence to the Club rules are expected." [10].

The board of the club made three decisions to suspend the applicant's membership and finally the board decided to revoke life membership. The issue was whether the applicant had been afforded a full and fair opportunity of presenting her case before the board made each decision. In reviewing the circumstances surrounding each decision, North J found that the club had failed to afford procedural fairness. In particular, his Honour identified the following aspects of each decision as indicating a failure to afford the applicant a full and fair hearing:

- the applicant had not been afforded sufficient time to respond to the first decision to suspend her membership made on 6 August 2014 as she was given no prior warning that the meeting was taking place; [33]
- the purported appeal hearing was invalid because it was not held in accordance with cl 8 of the club's constitution (which provided that an appeal meeting should be heard before a

general meeting of members). In any event, his Honour found that the appeal ought to have been held before a different organ of the club than the one which had made the decision to suspend; [53]

- the applicant was not given a full and fair opportunity to respond to the second decision to suspend her membership and revoke her life membership made on 16 February 2015 as the board only gave her a few hours notice of a meeting to be held on 16 February 2015 at which the decision whether to suspend her membership was to be discussed. That decision was also void; [61]–[62]
- the third decision made on 21 July 2015 to suspend the applicant's membership for 12 months was declared invalid because the board failed to provide her of particulars of the complaints made against her and the meeting proceeded in her absence because the club refused to grant her request for an adjournment. [69]–[70].

His Honour ordered that the decisions of 19 August 2014, 16 February 2015 and 21 July 2015 were void and that each be set aside.

#### **CORPORATIONS – WINDING UP – CONDUCT AND INCIDENTS OF WINDING UP**

#### Cadman v Aborigines And Islanders Alcohol Relief Service Ltd [2018] QSC 72 1

In this case Henry J made orders in the form sought by a liquidator, who was dealing with an unanticipated surplus. His Honour concluded that it was appropriate for a surplus to be distributed to a number of institutions with similar objects to the company in liquidation.

Henry J

16 March 2018

#### Background

This case was an application by a liquidator for orders granting special leave for the distribution of a surplus (as required by s 488(2) of the *Corporations Act* 2001 (Cth)) and for an order ("effectively a declaration") that he would be justified in distributing the surplus in specified proportions to four institutions, as resolved by a meeting of three members in February 2018: to the Gindaja Treatment and Healing Centre, the Yarrabah Aboriginal Corporation for Women, the Warringu Aboriginal and Torres Strait Islander Corporation, and Mookai Rosie Bi-Bayan. [1]–[2].

The company's Constitution envisaged that, upon winding up or dissolution, any surplus would be given or transferred to one or more institutions "having objects similar to the Company" and selected by the members at or before the dissolution. In this case there had been no such selection prior to dissolution, as no surplus had been contemplated. [8]–[9]. Further, at the meeting mentioned above, quorum under the Constitution had not been met. It was against this background that the liquidator sought an order. [12].

Henry J noted that the liquidator's approach had been to seek out institutions of the kind the members would likely have selected were they exercising the power under the Constitution. Further, following the meeting, the liquidator was seeking to give effect to the wishes of the members "as best they can be ascertained in these unusual circumstances". Importantly, each of the proposed recipients had objects similar to the company in liquidation. His Honour concluded that, in the circumstances, it was "entirely appropriate" to make orders of the kind sought, to "facilitate the payment of the surplus as proposed". [10], [13].

#### PROCEDURE – AMENDING, VARYING AND SETTING ASIDE JUDGMENTS AND ORDERS – EQUITABLE POWER OF SUPREME COURT TO SET ASIDE ITS OWN PERFECTED JUDGMENT – WHETHER MISCONDUCT BY LEGAL REPRESENTATIVES NOT AMOUNTING TO FRAUD IS SUFFICIENT TO ENLIVEN THE COURT'S POWER TO SET ASIDE PERFECTED JUDGMENTS

#### Clone Pty Ltd v Players Pty Ltd (In Liquidation) (Receivers and Managers Appointed) [2018] HCA 12

This decision concerned the equitable power of the Supreme Court of South Australia to set aside its own perfected judgments. The two issues which arose for decision in the High Court were whether the power of a court to set aside its perfected judgments extends to each of the following circumstances: misconduct by the party who succeeded at trial which does not amount to fraud; and where the unsuccessful party failed to exercise reasonable diligence to discover the misconduct during the earlier proceedings. The High Court unanimously found that actual fraud is needed and it is not a precondition to the exercise of the power that the party seeking to set aside the judgment had exercised reasonable diligence to discover the fraud during the earlier proceedings.

#### Background

In 1994, Players Pty Ltd ("Players") negotiated an agreement to lease certain premises from Clone Pty Ltd ("Clone"). [4]. Players was to use the premises as a licensed hotel and gaming premises. [4]. The lease contained the following clause:

"[Players] will upon expiration or earlier determination of the Lease transfer to [Clone] any Liquor Licences or gaming machine Licences held in respect of the premises for NIL consideration." [5].

The agreement was executed in August 1994, and Clone sent a photocopy of the agreement to each party's solicitors. [7], [9]. In September 1994 the agreement, or a copy of it, was sent to the Licensing Court of South Australia. [8]. What happened to the original lease was unclear. [9].

#### Original proceeding

A dispute arose between the parties in 2002, which resulted in Clone commencing an action against Players in the Supreme Court of South Australia in 2004. [11]–[12]. One of the issues in the proceeding was whether Clone was obliged to pay reasonable consideration to Players for the licences upon determination of the lease. [13].

The original agreement was not discovered, and was not in evidence at the trial. [15]. The photocopies of the agreement which were in evidence at trial showed a faint blue line that appeared to run through the letter "f" in the word "for", over the top of the letters "o" and "r", and then through the top of the letters "NI" in the word "NIL". [16]. Players argued that the word "NIL" had been struck through such that consideration was payable. [14]. Clone argued that the agreement provided for "NIL" consideration, and that the line was a mistake. [14].

Clone's senior counsel made various calls for copies of the agreement, and Players' senior counsel told the Court that a copy had been filed with the Licensing Court in September 1994 and that inquiries had been made. [17]–[18]. Without informing Players, Clone's solicitors made enquiries with the Liquor and Gambling Commissioner, as a result of which a third copy of the agreement was located in a

related file (as opposed to the main file) kept by the Commissioner. [19]–[20]. Clone's junior counsel inspected the agreement, and noted that it too contained a line through the word "NIL", but that it was not blue. [20]. He did not photocopy the document because he thought any copy would be discoverable. [20].

Players' solicitors attended at the offices of the Commissioner at a later date and inspected the main file, but did not request and were not shown the related file. [21]. Clone later gave a notice to the Commissioner to produce to the Court all files relating to the premises, and advised the Commissioner's secretary that the notice did not require production of the related file. [22]. The main file produced to the Court revealed a fourth copy of the agreement, which contained the same line through the word "NIL". [22].

The trial judge accepted Clone's argument and held that no consideration was payable under the agreement for three reasons, the third of which was that the agreement provided for "NIL" consideration. [25]. On appeal, the Full Court of the Supreme Court of South Australia upheld the trial judge's conclusion solely on the ground that the agreement provided for "NIL" consideration. [27].

#### Proceeding to set aside the judgment in the original proceeding

Players subsequently became aware of the third copy of the agreement, and in 2010 brought two applications to set aside the judgment against it on the basis of malpractice by Clone, and to obtain an order for a new trial. [32]–[33]. The first application was brought in the same proceedings that had been the subject of the trial judge's perfected judgment, and the second was a new proceeding brought in the Supreme Court. [32]. The trial judge accepted allegations that Clone had engaged in misconduct. [34]. On appeal, the Full Court upheld the trial judge's conclusion, but differed as to the nature of the misconduct. [34].

The trial judge accepted that the misconduct was a sufficient basis to enliven a discretionary power of the Court to set aside the judgment in the original proceeding (as varied in the Full Court), and ordered a new trial. [35]. The Full Court agreed, and dismissed the appeal. [35]. Clone appealed to the High Court.

#### Decision in the High Court

In the High Court, Clone advanced two grounds of appeal. [41]–[42]. The first was that "the Supreme Court's equitable power to set aside perfected orders, outside a statutory appeal, is limited to fraud and does not extend to forms of malpractice not amounting to fraud". [41]. After an extensive review of the authorities, a unanimous High Court accepted the ground, holding that "the general power of a court to set aside its perfected judgments requires actual fraud, although there are other discrete grounds to set aside a perfected judgment which were not in issue". [2], [43]–[60]. As fraud had not been pleaded or proved, the trial judge and the Full Court had erred in setting aside the judgment. [61]–[62].

The second ground of appeal was that "the Supreme Court's power to set aside its perfected judgment on the ground of malpractice not amounting to fraud was conditional upon proof of various matters which essentially required that (i) but for the serious malpractice the irregularly obtained judgment would probably have been different, and (ii) the party applying to set aside the judgment had exercised reasonable diligence". [41]–[42]. This ground raised the issue of "whether there is a further precondition requiring an applicant who seeks to set aside a judgment for fraud to establish that reasonable diligence was taken prior to the judgment to discover the fraud". [63]. After reviewing the authorities, the Court concluded that there was no such precondition. [2], [63]–[68].

In the result, the appeal was allowed. [72]. Practitioners will note that the High Court also emphasised that where there is an allegation of fraud in procuring a judgment, the proper course is to institute a fresh action seeking to rescind the perfected orders, rather than bringing an application in the original proceeding or appealing from the decision. [32], [61], [68].
